Instructed as Leading Junior Counsel leading [Drea Becker](#) from chambers representing the leading defendant in an undercover operation launched by HM Customs and Excise which lasted several months. The group were involved in a complex operation to receive raw tobacco leaf from abroad before processing and distributing it to a network of purchasers without paying the duty due thereon. Evidence demonstrated a sophisticated enterprise involving tobacco processing plants, multiple workers, including processors and couriers, and ties to other organised crime groups.
