# Prosecutor v. Sylejman Selimi- Commander of the Kosovo Liberation Army (EULEX Courts), 2012-2017

Lead Defence Counsel in tandem trials in Kosovo.

### OHCHR Investigation on Sri Lanka (OISL), 2014-2015

Submissions on behalf of three Sri Lankan NGOs, relating to the 30-year conflict between the Government of Sri Lanka and the LTTE (Tamil Tigers). 9 Bedford Row submitted detailed reports on aspects of the conflict, supported by evidence from documentary and open sources.

### Prosecutor v Momicilo Perisic (ICTY), 2012

Defence counsel -Acquitted all counts on appeal. 27 year sentence overturned and vacated.

### Prosecutor v Ramush Haradinaj et al (ICTY), 2012

Lead Defence counsel – Acquittal of all 37 counts (2008), Second Acquittal after first retrial in the history of the ICTY on all counts.

## Prosecutor v Limaj et al (ICTY), 2007

Lead Defence counsel - Acquitted of 7 of 10 counts.
