**Miriam Helena Boxberg is a Barrister with a unique practice ranging from international law and human rights to corporate responsibility and climate litigation. She works on high-profile cases before domestic and international courts.**

Miriam is currently employed by the Foundation for International Law for the Environment (FILE). FILE is the strategic collaborator and enabler behind hundreds of climate litigations and legal interventions around the world.

## **Background and Expertise**

Prior to joining FILE, Miriam worked as an Employed Barrister and Climate Lawyer at the leading environmental law charity ClientEarth. At ClientEarth, Miriam worked on the filing of ClientEarth's world-first derivative claim against the Board of Shell plc in the High Court of England and Wales. The claim alleges breaches of the directors' obligations under the UK Companies Act for failing to manage climate risk and properly prepare the company for the energy transition. The case gained unprecedented support from large institutional investors and fellow shareholders. It was widely covered in the press, including in the New York Times, Financial Times, The Guardian, Reuters, and many other outlets.

Before ClientEarth, Miriam worked as a Barrister and Associate Defence Counsel in pre-trial and trial proceedings before the Kosovo Specialist Chambers in The Hague. She also advised governments on instituting legal proceedings before the International Court of Justice under the Torture and Genocide Conventions.

Miriam previously worked for the British and Russian judges at the International Court of Justice, a position for which she was nominated by the University of Cambridge Faculty of Law.

Miriam also gained three years' experience as a lawyer at the leading American law firm WilmerHale LLP, where she advised Fortune 500 companies on high-value international arbitration and international trade disputes, including before the World Trade Organization, International Centre for the Settlement of Investment Disputes (ICSID), the London Court of International Arbitration, the English High Court and the Dutch Supreme Court.

Next to her legal studies, Miriam held various research positions, including at the Faculty of Law of the University of Cambridge and at the British Embassy in The Hague.
